

**State of Arkansas
Scan Line Specification for
Individual, Corporation, Fiduciary, Composite and Pass-through
Extension Vouchers**

Effective immediately, the scan line on all extension vouchers must use the correct font and font size. The scan line must be in the correct location. If the font, font size or placement of scan line is incorrect, extension vouchers will not be approved for reproduction.

Font: IdAutomationOCRa
Font Size: 9

There must be a half (1/2) inch clearance around the scanline.

Location:

Bottom of page to bottom of scan line – 16 mm or 0.63 inch
Right edge of paper to right edge of scan line – 25 mm or 1 inch
Left edge of paper to left edge of scan line – 53 mm or 2.08661 inches
Scan line is approximately 136-137 mm long.
RIGHT justified

Grid Location:

On a 6 line per inch/10 character per inch grid with the voucher forced to the bottom of the page, the scan line falls on the line between 62 and 63 or at the bottom of line 62, Space 75, right justified
