In response to the coronavirus pandemic, the Delaware Division of Revenue has extended the due date of the 2019 Delaware Form 1100 corporate income tax returns and payment of tax to July 15, 2020. When filing a return with the Delaware Division of Revenue, timely payment may be made any time up to and including July 15, 2020. A return filed prior to April 30, 2020, the original deadline, may still schedule a payment for any time through July 15, 2020. Taxpayers who have already scheduled payments can cancel them by contacting the Division of Revenue no later than 2 days prior to the scheduled payment date. The Division of Revenue will be able to assist the taxpayer in scheduling a new payment.
