

# Instructions for Form 720V Electronic Filing Payment Voucher

# 2019

**This voucher should only be used to submit payments due on electronically filed returns.  
This is NOT an extension form.**

**Filling Out the Voucher:**

Enter the **KY Corporation/LLET Account Number**. If you use an invalid account number, the processing of your payment may be delayed. **To obtain your valid Kentucky Corporation/LLET account number, please contact Registration at 502-564-3306.**

Enter the month and year of the entity's taxable year ending date as four-digits. Example: (MMYY) 1219.

Enter the Federal Employer Identification Number (FEIN).

Enter the entity's name, address, contact name, and telephone number. Do not use punctuation marks (quotation marks, periods, parenthesis, etc.) in the entity's name.

**Line 1:** Enter the corporation income tax payment amount.

**Line 2:** Enter the income interest and penalty amount (if applicable).

**Line 3:** Enter the LLET payment.

**Line 4:** Enter the LLET interest and penalty amount (if applicable).

**Line 5:** Enter the total amount of the payment.

**Preparing Your Payment**

- Make the check or money order payable to the **Kentucky State Treasurer**. Do not send cash.
- If the name and address of the entity are not printed on the check or money order, write them on the check or money order.
- Write the FEIN and the Kentucky Corporation/LLET account number on the check or money order.

- Cut the payment voucher along the dotted line below.
- Please place both the check or money order and the 720V payment voucher in the envelope together without staples or clips.
- DO NOT leave check stubs attached to checks.
- Mail with payment to **Kentucky Department of Revenue, Frankfort, Kentucky 40620-0021**.

The Kentucky Department of Revenue encourages taxpayers to make payments electronically. You can make a one-time electronic payment or you can register for a user name and password to make multiple and reoccurring payments electronically. Please visit [www.revenue.ky.gov](http://www.revenue.ky.gov) for details.

Entities that filed an electronic Kentucky tax return on Form 720, 720S, 720U, 725EZ, 725, or 765 can make payments electronically or mail a paper check or money order with Form 720V, Electronic Filing Payment Voucher.

If the 2019 tax return shows a refund or no tax due, do not use this payment voucher.

The Department of Revenue does NOT issue a notice of tax due prior to the deadline for payment.
