Note: Neither Maine Revenue Services nor the Bureau of Parks and Lands are responsible for undelivered, lost, destroyed, or stolen park passes. Replacement passes will be sold at the original purchase price. Photocopies or electronic photos of park passes are not accepted.

- The purchase of a Maine park pass(es) provides authorization for MRS to share your name and mailing address with the Bureau of Parks and Lands.
- MRS will issue park passes through July 31, 2025. For additional park pass options, fees, and rules, or to purchase your park pass **online** directly from the Bureau of Parks and Lands, visit: MaineStateParkPass.com.
- If you are filing an amended return, the correct amount of your charitable contributions and park passes **must** agree with the total amounts shown on your original return. Contribution and park pass amounts cannot be changed on your amended return.

Any voluntary charitable contribution you make on lines 1 through 8 above may qualify for a charitable contributions deduction on your 2025 federal and Maine income tax returns if you itemize deductions.
