# Instructions for Filing APPLICATION FOR AMENDED CERTIFICATE OF AUTHORITY OF LIMITED LIABILITY COMPANY

(Form L-10)

#### Item 1 Limited Liability Company Name

- (a) Enter the complete name of the limited liability company exactly as it appears of record on the current North Carolina Certificate of Authority.
- **(b)** A fictitious name to be used in North Carolina is required <u>if</u> the original name on the Certificate of Authority is not available for use in North Carolina. If a fictitious name is being used, enter the fictitious name of record with the North Carolina Department of the Secretary of State.
- **Item 2** Enter the state or country of formation.
- **Item 3** Enter the date the limited liability company was authorized to transact business in North Carolina.
- **Item 4** Enter the changes being made to the information contained in the previous Certificate of Authority. This document is to be used for the following changes only:
  - (a) Any changes to the name of the company; and
  - (b) A change to the jurisdiction of its organization.
- **Item 5** A current (within six (6) months) Certificate of Existence from the state or country of formation is required with this filing.
- Item 6 The document will be effective on the date and at the time of filing, unless a delayed date or an effective time (on the day of filing) is specified. If a delayed effective date is specified without a time, the document will be effective at 11:59:59 p.m. Raleigh, North Carolina time on the day specified. If a delayed effective date is specified with a time, the document will be effective on the day and at the time specified. A delayed effective date may be specified up to and including the 90<sup>th</sup> day after the day of filing.
