

## Corporate & S-Corporation Income Tax BARCODE SPECIFICATIONS

**Barcode Type:** 3 of 9  
**Width:** 1.6 inches  
**Height:** .35 inches  
**Clearance:** ALL around barcode: .25 inches  
**Location:** See Below

The location is based on a top left anchor point and must be exact.

The text does not need to be contained within the barcode. If the text is not included within the barcode, you do not have to place the text above or below it.

Each barcode is comprised of 3 variables:

- 1) Form Name
- 2) Tax Year – 2 characters
- 3) Page Number – 1 character

Each form containing a barcode is listed below along with the barcode name and its location:
