Who Must File

Anyone who is not required to register as a verified practitioner, who does not want to disclose their personal social security number (SSN) on Form N-848, and who would like to speak with the Department of Taxation (Department) on behalf of another taxpayer must register with the Department and obtain a Tax Matters Representative (TMR) Identification Number (TMRID). The issuance of a TMRID does not in any way replace the need for an executed Form N-848 giving the TMR the authority to speak to the Department on the taxpayer's behalf. Once a TMRID number is issued to a TMR, the TMR may use the TMRID on all Form N-848s.

The following persons are required to register as verified practitioners online at http://hitax.hawaii.gov or using Form PPS-12: (1) Attorneys; (2) Accountants; (3) Enrolled Agents; (4) Enrolled Actuaries; (5) Enrolled Retirement Plan Agents; and (6) All other persons who represent taxpayers and receive compensation for their services.
