

1D barcode instructions for software developers:

The 2 digit year code should reflect the tax year "18"; The Vendor Code field should contain the software developer 4 digit assigned code for identification purposes; The Form ID is assigned to each individual page by the Department of Revenue. The name of the form page is listed next to the Form ID code. Entries in the 2018 1D Barcode Layout page highlighted in yellow are new additions. Entries with strike throughs are removed for the current tax year.

A one dimensional barcode must be generated at the top of every page of every individual income tax form and schedule.

Location on page: Printed on the upper-center portion of the return with ¼ inch of surrounding white space.

Size and type: 30 point, FREE 3 of 9 barcode font

For the 2018 1D Barcode Layout, please be sure to use the 2018 Column for form numbers. 2017 numbers are in the layout as reference.
