# OKLAHOMA TAX COMMISSION GUIDELINES FOR SUBSTITUTE FORMS

*Oklahoma forms should be reproduced as closely as possible to the official form while also following the National Association of Computerized Tax Processors (NACTP) rules for form reproduction.*

All developers who reproduce Oklahoma tax forms must submit a “Letter of Intent (LOI)” to the Oklahoma Tax Commission each year. The LOI may be submitted by fax or email. Please email Crystal Cameron at [efiledevelopers@tax.ok.gov](mailto:efiledevelopers@tax.ok.gov) for a copy of the LOI. See page 3 for other contact information.

## New for TY2020

Forms 511, 511NR, 512, 512S, 513, 513NR and 514

- A new deduction is allowed for contributions to a home-buyer savings account. (Form 511 and 511NR ONLY)
- The Credit for Qualified Software or Cybersecurity Employees was added to the Form 511CR. (Form 511 and 511NR ONLY)
- The Credit for Railroad Modernization on the Form 511CR was modified to increase both the individual credit amount and the total annual credit cap.
- A donation may be made from your refund to support the Oklahoma Silver Haired Legislature and Alumni Association Programs.

OCR Requirements

Due to changes in processing, the following additional requirements will be required on all 2020 income tax forms:

## Form Field Requirements

Text and Numerical Fields: Fonts are to be *Arial 12 Point 10 Pitch*. Text fields must be ALL CAPS.

Exception: Form instructions, line information, preparer fields and signature fields can be smaller than specified and in lower case in order to fit the information in the available space, as needed.

Round all numerical amounts to whole dollars. If the return has pre-printed zeros in the cents fields, please replicate the zeros or ensure they are printed from the software.

Exception: Returns that do not have pre-printed zeros and do not require rounding to whole dollars. Example: Oklahoma Corporate Return Schedules.

Numerical fields must be right justified.

Text fields must be left justified.

Negative values should be presented with the minus sign to the left of the amount.

## Substitute Forms Approval Process

Forms should be submitted via PDF attached to an email whenever possible. This will help ensure a faster turnaround time.

Submit one .pdf file for each form being submitted for approval. *[for testing]*

- Each file must include the following:
  - Blank form *[layout]*
  - Form with useful data (ex: 0.1234) *[calculation]*
- Each submission should include a cover letter identifying the forms submitted, the company name of the submitter, and the name, address, phone/fax number and email address of the form contact.

Approvals are processed in the order of delivery and any approvals or requests for changes will be sent back within 10 business days.

Approval or request for change notifications received will be sent to the developer via email regardless of how it is submitted.

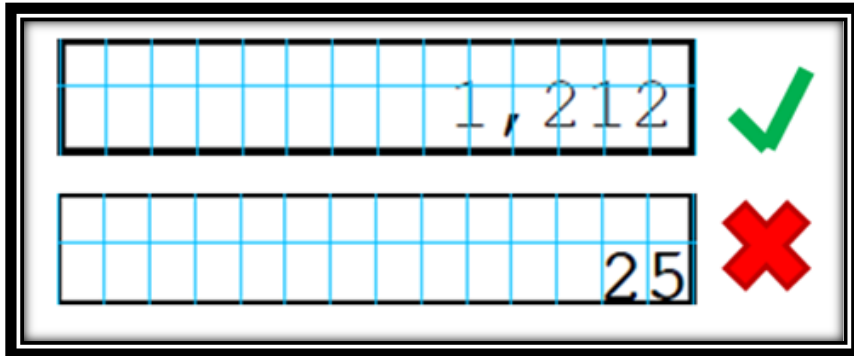

## Oklahoma QR Barcodes for TY2020

### QR Barcode Dimensions

Code Type: Text

Text Content: Year (4)/Form Number (5)/Pages (2)/Source (1)/Vendor Code (4) – Both alpha and numeric characters are used. Alpha in caps.

Error Correction: L-Appx 7% (default)

Margin: 0 blocks

Scale: 1X

Code Color: 000000

This generates a QR Barcode with dimensions of 0.5833” by 0.5833” that is resized down to 0.5” to 0.5” before placing on the form (0.5 inch minimum).

Encoded carriage returns are prohibited.

Maintain a quiet zone (white space) of 4 modules around QR Barcode as shown in the example in Figure 1 on page 5.

**2020** – For all year specific forms. All non-year specific forms get 9999 for the year. Example of non-year specific form: 99990020001WXXXX

**00511** – Form number (if a form number is less than 5 characters, zeros filled to make 5. For example, Form 511 would be 00511).

**01** – Page number (if a form has more than one page with data that a taxpayer fills out, each page's barcode reflects that page's number. Instruction pages do not get barcodes).

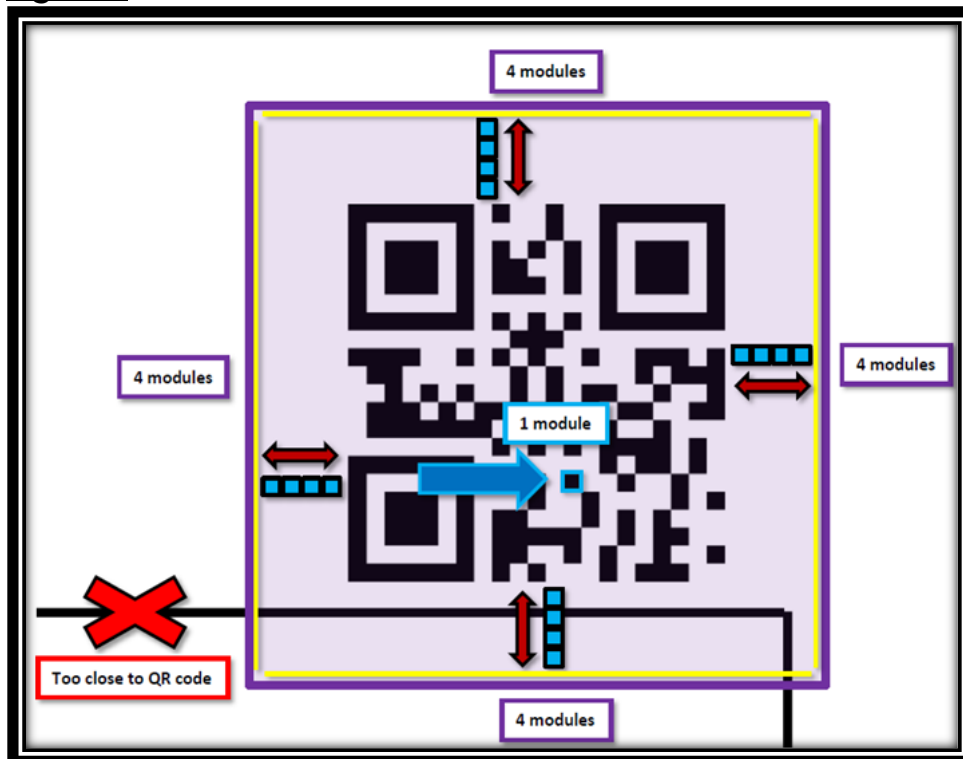
**D** – Source code (where the form came from. Examples: W for web, M for mail out, D for developer, etc.).

**XXXX** – The four X's after the Source Code are the Vendor code. Vendor codes should be included in the barcode rather than the form itself. If no vendor code, the four X's are replaced with four zeros.

Example of barcode with vendor code: 20200051101D1695 with 1695 being the OTC vendor code.

Example of barcode without vendor code: 20200051101D0000 with 4 zeros taking the place of the vendor code.

# PDF 417 2-D Barcode

The following guidelines are to be upheld for all tax years and all form types that utilize a 2-D barcode. Those form types for the 2020 tax year are OK511, and OK511NR. Each form will have four 2-D barcodes.

## Field Standards for the 2-D Barcode

The delimiter between fields will be “Carriage Return”.

Unless otherwise stated in specifications, all numerical fields are 11 characters.

Negative values should be formatted with the minus sign placed before the numerical characters. Example: -100

Use whole dollars only.

Date format should be MMDDYYYY.

Unless otherwise noted, check boxes should export the following values:

Checked = X

Not Checked = Null

Do not zero fill fields, use Null.

Truncate any characters over the specified field limit (example: name or address longer than field length).

Do not use any punctuation (no commas, periods, percent signs). Alpha fields should contain only A-Z. Numerical fields should contain only 0-9.

## Placement of 2-D Barcodes

The four 2-D barcodes must be placed on a separate page. They will be arranged vertically, in order and in center alignment. An example for this page can be found at the end of this document. This page will have the following header: (The below images will be replaced with current tax year once the forms have been finalized.)

## 2-D Barcode Dimensions and Specifications

X dimension = **14 mils** minimum

Y/X ratio = **3**

Error Correction Level (ECL) must be set to **4**.

Barcode must be set to **ON**.

Exceptions:

- The 538S return dependent SSN information is included in the 2-D barcode. The 538S form should be attached to the 511 return when mailed to OTC.
- If there are more than 5 dependents on the 538S, attach a separate page with the additional 538S dependent information.
- 538H information is not included in the barcode. The 538H should be mailed in with the return to OTC.

## Barcode Testing Process

Those software developers who are supporting Oklahoma 2-D barcode returns must test with OTC prior to releasing their software to clients or the general public.

## Test Criteria 511 & 511NR

Test returns for Form 511 are to be based off the ATS test criteria available on the FTA SES (Federal Tax Administrators State Exchange System) website <https://taxadmin.kiteworks.com>. Test returns for form 511NR should be done using the same ATS test criteria with developer discretion to use whatever residency status and federal data, but ensure the federal column of line 2 is populated.

There should be a mention on the 2-D barcode page of 5112-D and 511NR2-D forms to remind taxpayers that the 2-D barcode page is required to be sent with their 2-D returns. It should NOT be attached with the payment voucher, form 511V. Please see the example on Page 9.
