## 760CG / 760PY / 763/ 770 – Special Visual Message Details

### Visual 'XXXXX' Message – Printed Copies of e-Filed Returns

If a taxpayer opts to print/save their e-Filed return, Virginia Tax now requires this visual message of 'XXXXX' to be added to Income Tax returns to indicate the return **was / will be e-Filed**. The 'XXXXX' should be added to the latest point in the "to be e-Filed" process or after the return was e-Filed.

Internal screening procedures will use the 'XXXXX' in an effort to avoid reprocessing the return if taxpayers mail in a printed copy.


Use these locations for the 'XXXXX' message.
