• If the return was filed with the Commissioner of the Revenue for your locality, make your check payable to your local Treasurer and mail the payment to your locality so that the payment will be credited to your account at the local office.

Do not send a copy of your return with your payment. If you send a copy, the payment will not be posted properly to the account.

COMPLETE THE PAYMENT COUPON BY INCLUDING THE FOLLOWING INFORMATION:

- The federal identification number (FEIN), which must match the return.
- The name of the fiduciary (estate / trust / unified filer).
- The correct start and end of the filing periods, which must match the return.
- The amount of the enclosed payment.
- · Make sure that the FEIN is written on the check.
